#### MESSAGE FROM THE PRESIDENT

One word for Julianna Koob, the presenter at the dinner on the 13<sup>th</sup>: **Powerful.** It truly was one of the best presentations I've attended. Here are a few take-a ways. 1) The majority of south central New Mexicans believe that a woman's decision to have an abortion should be between her, her family, and her doctor. 2) New Mexico is threatened every year with anti-

abortion legislation; we are surrounded by states where women have no access to abortion and the number is growing. 3) If we are going to protect a woman's right to a safe and legal abortion, we must be willing to talk to our legislators and others about a personal experience (whether our own or people we know).

#### **OBSERVER REPORT** by Susan Schmugge

South Central Solid Waste Authority Regular Meeting Nov. 16, 2017

Present: Solis, Rawson, Gandara, Dr. Garcia, McMahon

Absent: Miyagishima, Vasquez, Perea

After the Director's Administrative & Financial reports the Authority unanimously approved 4 resolutions:

The first 2 were a renegotiated Joint Powers Agreement that separates fiscal roles between the Authority, City of Las Cruces, and Dona Ana County and allows the Authority to issue bonds with any one of the other 2 agencies. Among immediate changes will be quarterly instead of monthly meetings. The new agreement allows the Authority to expand its role in our region. The City of Las Cruces will still provide financial oversight, accounting and audit services. Approval of accounting resolutions followed. The next meeting will be in January, 2018.

## **OBSERVER REPORT** by Mary Ellen Knapp

Las Cruces, NM City Council, November 6, 2017 Regular Meeting

Mayor and all Councilors were present

Items of particular interest were:

The president of the Greater Las Cruces Chamber of Commerce and the owner of Pic Quik convenience stores have requested the Council reconsider the 2014 Minimum Wage ordinance.

The unexpected announcement of a January 1, 2018, cost-of-living increase created great concern within the business community. The president of the Chamber of Commerce and the owner of Pic Quik stores addressed the Council, requesting review of the ordinance prior to the swearing-in of newly elected councilors at the November 20, 2017, Council meeting.

**APPROVED** - Authorized sale of 201 N. Main property, formerly known as the Camunez Building, to

Las Cruces Community Partners. Agreement was amended to give Council final design approval of east and south facades. (7 ayes)

**APPROVED** - Adopted distribution of City's portion of proceeds from sale of 201 N. Main property.

Las Cruces' 50% share of proceeds is \$100,000, which will be invested 50% to Affordable Housing Trust Fund and 50% to Economic Development Fund. (6 ayes, 1 absent)

**APPROVED** – Adopted the Renovate Main Street incentive Program, which matches, dollar-for-dollar, private investment of \$25,000 for upgrading downtown property. Total program funds available January through December, 2018, are \$250,000. (7 ayes)

#### **OBSERVER REPORT** by David Neal

Meeting attended: Deming City Council
Date submitted November 14, 2017

Regular Meeting

One member of five absent

At this Council meeting there were regular items including Proclamations, approval of appointments to various boards and minutes' approvals.

It is noted that during a discussion of a proposed bond proposal Councilman Dr. Victor Cruz expressed opposition to such. However, when a motion was made to approve the general obligation bond question, Dr. Cruz voted in the affirmative. In fact, all votes by the council were unanimous--no dissenting votes on any issue

In addition, Council approved a 150' tower proposed by Verizon. It was not disclosed, however, who owns the land where the tower is to be built. The city may very well own the site/property and may be receiving monthly fees for the tower. This was not disclosed.

As at all other Council meetings, the Mayor deferred to the City Clerk for explanatory remarks on all issues.
