The items to be discussed include Judicial Reform, Reproductive Rights, Nuclear Waste Storage, Effective Strategies LWVUS is Taking to Accomplish the League's Vision, and Promoting the League's Work for Impact, Relevance, and Visibility.

Each delegate will have five minutes to summarize items for us to consider, or an important piece of information we need to be aware of, followed by member reactions and suggestions on how we might implement those ideas into our local's work. The meeting will conclude with a process that will identify priorities for our local to pursue.

LWVNM Delegates enjoyed hearing from two speakers: Henrietta Saunders, Treasurer of the League of Women Voters of the United States, and Valerie Plame, the featured speaker at the banquet. Saunders brought word of efforts at the national level to become more solvent,

better managed and to reinvigorate the League's central missions. The announcement of the 2017 LWVUS Council highlights this topic. Valerie Plame spoke on the topic of nuclear proliferation.

Clarification of LWVUS positions and by-laws included the requirement of concurrence by state and local Leagues.

Three studies were approved, with invitations to all League members to join. The studies are: Public Lands, Nuclear Waste Storage Issues and Health Care Position Clarification. Be alert for more information as the studies progress. Concurrence positions and changes to by-laws will be announced in an upcoming *La Palabra*, so be alert for these to appear.

Newly installed LWVNM President Judy Williams spoke about the need for strong reaffirmation of the League's non-partisan BUT political status: The League does NOT endorse candidates. The League DOES ENDORSE positions.

June 2017 Voter Message from The President

Greetings Members of LWVGLC,

I am pleased to tell you that we had a very productive three- hour board meeting May 4th. Besides taking care of general business, we spent half the time discussing our vision for the League, what should be our focus, what we do well, and what we could do better. We will be inviting your input during The Program Fiesta in September. Your Directions to the Board from the Annual Meeting helped us to frame the discussion. Thank you. I will be reporting on the Board's response to the Directions at each meeting as we address them. So far, these are the directions we have addressed:

- We developed and passed a policy on responding to requests from outside entities for publicly endorsing a position. "Requests for LWVGLC to make public statements/positions may be approved by the board via email by a minimum of 4 members, except if any members object, a complete discussion will be conducted and the request will be voted on at the next board meeting."
- 2. Request for a strategy to go digital on voter services publications: The board decided to make Voter Services a priority for the next two years. We will focus our efforts on 3 areas: voter registration, voter information, and voter turnout. Plans are to engage the membership in discussion and planning and increase member participation in these efforts. We need to figure out a strategy to get voter information to the public transitioning to more use of digital media.

- 3. The board concurred with the direction for the need to appoint a Public Relations Director. We will discuss this at the next board meeting as well as discuss the appointment of an Observer Corp Coordinator.
- 4. Request for more lunch meetings during winter months. So far, breakfast or lunch meetings are planned for November, December, January and February.
- 5. Request for replacing some Dinner with a Leader sessions to a Discussion of Issues. The board concurred. We will have a discussion on issues addressed at the state convention during the July meeting.

2018 marks the 50th anniversary of the LWVGLC! We need to start planning for a BIG CELEBRATION!!! Marjorie Burr is chairing the committee. Contact her if you want to help.

The board approved the reimbursement of the registration fee for the state convention for delegate members up to the amount budgeted.

OBSERVERS' POST

Las Cruces City Council Meeting, Monday, June 19, 2017: Organ Mountain Desert Peaks Resolution Submitted by Dale Yeo

The City Council Chambers was quite full, mostly for discussion and vote on Resolution 17-205 in support of the Organ Mountains Desert Peaks National Monument.

The succinct form of the resolution was presented as the following:

- 1. Support the Monument
- 2. Oppose any efforts to rescind, reduce or otherwise harm the Monument
- 3. Oppose any changes to the Antiquities Act

For everyone's information, the Resolution was read aloud in its totality and then public testimony began. Each person was allowed three minutes that was later changed to two as the Mayor saw how many people wished to speak. From my notes the breakdown of the number of speakers pro and con was the following (not counting the questioning period by the Councilors):

Pro: 27 Con: 5

The Con speakers could be divided into two categories: three ranchers with concerns about grazing and their private lands and two speakers who objected to the wording of the Resolution. The ranchers' concerns were presented sensibly, but their concerns about grazing and private lands had already been resolved in the original Monument plans. No ranchers or anyone else appeared to say they had been hurt in any tangible way by the Monument.

Pro speakers represented wide-ranging interests in the community: Teachers, Archaeologist, NMSU Wildlife Ecologist, Photographer, Religious Leaders, A Home Builder, A Mother, NMSU Wildlife Federation Representative, HTC (High Tech Consortium) Representative, Heritage Tour Owner, Volunteer at Dripping Springs, Restaurant Owners and well-know monument backers, Jeff Steinborn, Nathan Small, Bill Soules, David Soules.

Several who spoke were especially enthusiastic as most said their businesses were doing much better now and since they routinely talk to their customers they could attribute a significant portion of it to visitors attracted by the Monument.

Councilor Levatino interjected at another time that she had polled businesses in her district and all but one said they had benefited from the Monument in one way or another.

Each Councilor was then allowed to comment and question people from the public who had spoken and who might be there and had not yet spoken.

A discussion occurred about the third point of the Resolution- the Antiquities Act of 1906 < https://www.nps.gov/history/local-law/anti1906.htm >

After reading this law aloud and some discussion, it was moved and approved to strike Part 3 from the resolution. Its proponents agreed and are planning to bring it up again later. This had not been part of the original Resolution, either.

The City Council voted unanimously for approval of Resolution 17_205.

Treasurer's Talk
