

#### **Old Business:**

**Studies and Committee** – reports and discussion tabled from May meeting. Sue Cain was absent; there was not a report given on immigration.

**Action Items** – May 2015 Board Meeting – Issues raised by Erika Graf-Webster After a lengthy discussion on the Ocotillo Institute Empowerment Congress Workshop and League participation in Fun Camp; the Board decided that although both organizations work on similar principles it is not feasible for the League to get involved in another project at this time. We are adding two new committees this year - immigration and metro court; however, we might consider future collaboration.

Brainstorming of activities to encourage young voters was discussed. The purpose is to have three teams – High School, DACC and NMSU. Gwen Hanson and Erika Graf-Webster attended a meeting at the Las Cruces Professional Development Center with Bonnie Votaw and Wendi Miller-Tomlinson. The meeting focused on the High School efforts led by Bonnie Votaw with the help of Wendi Miller-Tomilinson, to develop curriculum lessons dealing with voting issues and also to utilize the Excel high school program to get a student intern to develop new tools, such as smart-phone apps. Another venue is to engage the student governments in finding events where the League could promote their message of the importance of voting and could actually register new voters. Wendi Miller-Tomilinson is the Director of Secondary Education for the Las Cruces Public Schools system. Wendi is in the process of joining the League and very interested in helping with our project. According to Bonnie Votaw, Centennial High School is hosting the NM State Student Council Conference April, 2016. The President of the Centennial High School Student Council will be invited to our August Board Meeting, to be held at the Professional Development Building.

Rosemarie Sanchez, Emma Armendariz, Kelly Burnham and Yvonne-Magdalena Flores are working with the NMSU students. Rosemarie has begun to make contacts.at NMSU. After a discussion Erika Graf-Webster moved that the League focus on the high school plan that Bonnie Votaw submitted. Motion was seconded by Marcia Anderson. Motion carried.

## KRWG Las Fronteras: A Changing America Public Television Series Spanish and English: Dual Language Program -

As a means of keeping the community informed about new programs in the public education system, the League of Women Voters, Las Cruces Public Schools (LCPS), and KRWG have been collaborating on an education series. The Dual Language program, an effort to introduce Spanish and English speakers to each other's languages, was the topic of the most recent discussion. Mari Rincon, LCPS Coordinator for Dual Language and Migrant Education, and Kathy Norris, Principal, Fairacres Elementary school, introduced the program. Theresa Saenz-Telles, multi-age bi-lingual teacher, presented information about the actual classroom experience.

The mission of the program is to encourage students to become bilingual and literate in two languages, Spanish and English. Students are immersed in two multi-age classrooms, kinder through second and third through fifth grades. Classes are held at Fairacres and Desert Hills Elementary schools. Students remain in one classroom rather than being pulled out of and shifted from classroom to classroom. Throughout the day, learning occurs both in Spanish and English. The teacher now has a major role as facilitator. Students mentor other students and work cooperatively to get the best results from assignments. This environment demonstrates that each child's culture is worthwhile. The teacher can focus on interests and learning styles of the students who gain leadership skills and receive instruction at the needed skill level. Students focus on the real world. Diversity and mentoring among the multi-age students lead to creative learning.

There are about 40 students in the program at Fairacres. Many of the students are Spanish-speakers only. Desert Hills Elementary has more English speakers. Parents sign-up for the program. Multi-age students are assigned in equal numbers (e.g., six each in kindergarten, first, and second grade, etc.). Students are selected by lottery, and Spanish speakers have priority to fulfill English as a Second Language (ESL) requirements. Before the program was started, parents were surveyed and showed support for it.

Presenters described the program as a breath of fresh air. Working with other teachers creates support among the teachers, and new technology encourages creative activity that often originates from the students themselves. The presenters felt this program was a huge leap in the field of dual language instruction because it occurs in a self-contained classroom and Spanish and English are spoken continuously.

Ms. Saenz-Tellez described a learning experience that occurred in her classroom in collaboration with the Doña Ana Arts Council (DAAC). Working with DAAC, the students from both schools showcased their projects in a public event. The students created a TV Talk Show using a PowerPoint presentation to demonstrate the knowledge they have acquired in the classroom. Using Dr. Seuss' book, "Oh! The Places You'll Go," the students read the book, did a character analysis, acted out parts, recorded it, and made a film. These are two examples of the creative learning taking place in this special dual language program.


## COMMON CAUSE - Public Campaign Finance

In February of 2015, Craig Fenske from Common Cause NM was invited to the Election Procedures Committee meeting to discuss the topic of public funding of election campaigns.

In early July, five members of the Election Procedures Committee: Ardyth Norem, Rosemarie Sanchez, Yvonne Flores, Erika Graf-Webster, and Gwen Hanson met with Craig Fenske and Heather Ferguson. The purpose was a request for statements of support from the League for the proposal by Common Cause to the Las Cruces City Council, July 13, 2015, during a Work Session – for public funding of Las Cruces municipal election campaigns. The League's statements of support would be part of the presentation. Gwen Hanson and Erika Graf-Webster agreed to participate.

Monday, July 13, 2015, Craig Fenske presented the proposal of Common Cause to the Las Cruces City Council for public funding. Statements of support were offered by Erika and Gwen, as well as NMSU Professor of Government, Nancy Baker. The presentation was well-received, and future plans for another work session to further the conversation between Common Cause and the Mayor and City Council was discussed.

#### **LWVNM Special Session Update**

June 13, 2015

After weeks of bipartisan negotiations surrounding capital outlay funding, New Mexico legislators reconvened Monday, June 8, in Santa Fe for a 5-hour special session.

Along with reviving the 2015 capital outlay package, which includes increased funding for senior centers and higher education institutions, the legislation passed on Monday also allocated \$300,000 to the Administrative Office of the Courts and \$4 million to the Department of Health. Although these actions were critical in keeping New Mexicans working and providing necessary services to some of our most vulnerable populations, it came with a compromise of tax breaks and incentives.

The Special Session raises several serious procedural questions: Should tax packages be included in a one-day session that permitted very little input from the public? Even more important, where was the transparency and accountability in the negotiations that occurred before lawmakers were convened?

#### What the Tax Bill included:

- Restored the unreimbursed medical expense deduction, which is slated to expire this
  year. According to the Governor's Office, about 300,000 New Mexico taxpayers have
  claimed this deduction. The administration has said that nearly half of those using the
  deduction earn less than \$25,000 annually.
- Restored the gross receipts tax deduction for trade-support companies that locate in a border zone.
- Clarified two provisions relating to the double taxation and loading fees on gasoline or special fuels.
- Increased the 'Angel Investor Credit' to \$2 million and continues tax credits for technology companies and research and development.

Unfortunately, when legislators were given a chance to support Representative Matthew McQueen's solar credit amendment (same language as the LWVNM 2015 endorsed bill – SB391) to the tax package legislation, it was defeated 33-29. The vote was along party lines even though an overwhelming majority of legislators had passed this renewable energy tax credit extension in the regular session.

LWVNM will continue to keep you informed about upcoming interim hearings, changes or challenges to laws, and other ways you can get involved and make a difference in the policy that shapes the lives of New Mexicans. #### DRIPPING ON

In 2013, the NM legislature appropriated funds for the Interstate Stream Commission to develop an update of the State Water Plan of 2004. On June 30, 2015, the consultants hired by the ISC are supposed to present the technical platform and coordinated regional policies and programs to that Commission. Each of the sixteen regions was charged with developing implementation programs for that region, subject to ISC revision and approval, for melding into a new statewide plan.

Here in Region 11, the Lower Rio Grande, i.e. mostly Dona Ana County, six work groups were established: environmental, agricultural, commercial and industrial, technical, quality of life/big picture, and community engagement. The volunteer work groups labored through the spring to bring forth programs and policies and projects to present to the volunteer Steering Committee, which then would present to the ISC.

At press time, questions await answers: how current will be the technical data provided on deadline by the consultants? How faithfully will regional input be honored, given the desire at the state level for homogeneity? What representations will be made to the 2016 30-day session of the NM legislature, in terms of funding and of legislation?

#### Women's Suffragist Memorial

Dear League Leader,

I am writing to inform you that the League of Women Voters of the United States (LWVUS) has agreed to become a partner with the Turning Point Suffragist Memorial Association (TPSMA) in creating a memorial that celebrates the fight for women's suffrage and its relevance today. This decision is particularly timely in light of the upcoming 100<sup>th</sup> anniversary of the ratification of the 19<sup>th</sup> Amendment in 2020.

TPSMA has been working to ensure that the proud history of the successful struggle for women's voting rights will be permanently commemorated at the Turning Point Suffragist Memorial, located on two acres within the Occoquan Regional Park in northern Virginia. This location was selected because it is in close proximity to the former location of the Occoquan Workhouse, where dozens of suffragists were incarcerated in 1917 for picketing the White House. The inhumane treatment of those brave women became public knowledge and in turn became one of the significant turning points in the fight for the 19<sup>th</sup> Amendment. Of course the history of the fight for women's suffrage is much longer and broader, with many turning points less celebrated but equally significant. Many critical milestones will be commemorated on the 19 informative stations that will be installed throughout the park. Since suffragist leaders, like our founder Carrie Chapman Catt, built no monuments to themselves, this memorial will be one of the very few physical reminders of the importance of their movement.

The LWVUS Board has agreed to become a partner and has appointed Executive Director and Arlington, Virginia League member Nancy Tate to represent the League on the TPSMA Board. In addition, the LWVUS Board voted unanimously to make a \$1,000 contribution to the memorial. That contribution will ensure that the LWVUS name will be included on the Donor Wall at the park. Although the park is being built and maintained by the Northern Virginia Regional Park Authority (now known as NOVA Parks), the funds for the memorial itself must be raised privately. TPSMA's initial goal is \$1 million by November 30, 2015 and they are reaching out to many individuals, groups, and corporate donors.

We encourage all Leagues and individuals to consider making their own donations. Interested Leagues can learn more by visiting the Turning Point website, <a href="www.suffragistmemorial.org">www.suffragistmemorial.org</a>. Donations can be made through the website or by mail to TPSMA, 5400 Ox Road, Fairfax Station, VA 22039. Gifts of \$1,000 or more will be recognized on the Donor Wall, and three state Leagues (Colorado, Tennessee, and Virginia) have already contributed at that level. TPSMA is requesting that donations be made by October 15, 2015, to enable them to stay on schedule for building the first phase of the memorial.

We believe that this partnership is about more than building a memorial to the suffragists, significant though that is. The goal is to create a place and the momentum to educate and inspire present and future generations to continue the fight for equal rights. The design already calls for significant efforts since 1920 to be highlighted. Our involvement in the memorial can only strengthen the story.

Whether or not you choose to support the memorial, please plan to be part of efforts over the next five years to celebrate both the 100<sup>th</sup> anniversary of women's suffrage and 100 years of continuous League efforts in Making Democracy Work. We have a wonderful opportunity to showcase not only our proud history but also the many contributions that Leagues across the country are making today – and every day.


#### Forum guests include:

Management Reports:

Jaclyn Leyva, newly hired Housing Choice Program Manager (she is the administrator of the HUD Section 8 rental vouchers) reported that June 30 will be the one day that people can apply to put their names on the waiting list for receiving a rental voucher. This voucher may be used for rental of units in public housing (owned by MVPHA) or in units owned by private sector landlords approved by MVPHA. There are presently about 500 people on the list who applied last year and Ms. Leyva said they expect 400-500 more this year. The program has enough funding to issue 15-20 vouchers per month. The need is much greater than the funding. The Section 8 program in MVPHA has a current rating of "troubled" by HUD and the Authority is working hard to change this.

**Executive Director:** 

Juan Olvera, new Executive Director, responded to a question from the Board about setting up a Residents" Council. Mr. Olvera is making changes to administrative policies and these will be presented to the Board for its approval in the next few months. These will include the procedure for the waiting list and hiring help to set up a Residents' Council. Board adjourned to go into executive session to discuss the contract with the Bernalillo County Housing Authority that had been hired the aid with Section 8 Program difficulties.
