## **Program Planning Meeting**

The annual Program Planning Meeting is set for Feb. 13 at 2:00 p.m. via Zoom (our regular meeting day). This is an opportunity for League members to identify topics for study and advocacy for the coming year for the local League and for the next two years for the state League.

To prepare for the discussion, pull out your member handbook/directory and review our local positions on pages 37-49. Identify positions that may need updating as well as new areas for study. Similarly, you might review the state League positions at www.lwvnm.org.

Keep in mind that the League's ability to advocate on issues depends on having a relevant position and, in turn, positions are derived from study followed by reaching a consensus on members' views. (Alternatively, we can consider concurring with a position reached by another League.) It is our study of the issues that gives our advocacy credibility.

Proposed local program items are submitted first to the board for approval and then to the membership at the annual meeting in April. After the annual meeting, changes can be made in the adopted program if discussed at a general membership meeting and then approved at a subsequent general meeting. Proposed state program items are addressed through the state board and the state convention scheduled for April.

Program recommendations are considered based on three criteria: 1) Is there widespread member interest? 2) Is this a timely issue? 3) Is government action the most effective way to address the problem?

If you aren't able to attend the February 13 meeting but want to submit program suggestions, please email <a href="Kathy">Kathy</a> and/or Eileen with a brief description of your suggestion. We look forward to a lively discussion.

### Co-Presidents' Messages (cont.)

Democracy Work Award to honor community leaders of civic projects that contribute to strengthening our democracy. Leaders of the Getting to Know Your Local Government project, Josie Miller, Jamie Patterson, and

Jamey Rickman, developed "real world" learning experiences for high school students. While there were many educators and city employees involved with the project, the three leaders organized it. Josie and Jamie are content specialists with Las Cruces Public Schools. Jamey is the Community Engagement Manager for the City of Las Cruces.

Las Cruces Public Schools educators developed lessons about local government that were studied in classes with volunteer teachers during February. The culminating project brought students from six high schools to City Hall, where employees presented four real city problems to the students. The students were then randomly divided into four teams to investigate one of the problems further and to develop solutions to it. The intention was for the team judged to be the most successful to attend a City Council meeting to present their solutions. All of the teams did so well that each was going to be invited to share their suggestions with the City Council. Then COVID happened and the final piece of the project was cancelled.



High school seniors were divided into teams and assigned a mentor during this unique experience.

The valuable project was very effective in connecting high school students to civic participation by investigating and collaborating with other students. We will let you know when the project will be celebrated.

An updated LWV of New Mexico Education Position will be circulated soon. Parts of it were approved by the State Board on January 16<sup>th</sup>. It describes and addresses a high-quality, equitable education system. There will be meetings scheduled to discuss the updated position and to address consensus questions related to it.

## LEAGUE MEMBERS CONTINUE TO EXPLORE IMMIGRATION REFORM

Crystal Massey from The American Immigration Council (AIC) met with LWVSNM members on Jan. 26 to discuss strategies to work on humane immigration reform. While President Biden has already signed a number of executive orders that have reversed some of the Trump administration policies, there are ongoing concerns and AIC wants to ensure the new administration will address humane immigration reform as a priority.

Among some of the actions they have planned: 1) Give immigrants a pathway to citizenship after an eight- year waiting period; 2) Institute a four-year extension of the DACA program; 3) issue executive orders on asylum at the U.S. Mexico border, refugee resettlement and the reunification of migrant families; 4) Restore a program that allows certain children in the Northern Triangle to apply for refugee status in the U.S. from their home countries; 5) Roll back a Trump rule that sought to block asylum seekers who pass through another country to the US (3<sup>rd</sup> Country Rule);

6) Create a task force to reunite migrant families who were separated at the U.S. Mexican border; 7) Raise annual refugee intake from the record low 15,000- person ceiling to 125,000.

Crystal emphasized there are still close to 70,000 migrants currently in the Migrant Protection Protocols (MPP) program living in limbo in Mexico border cities with no plan in place. The AIC will advocate that Congress pass humane immigration reform laws for real long-term solutions to immigration.

The LWVSNM Immigration Committee has also suggested important actions for the League and the Board to consider such as immediately writing letters to Congress and raising public awareness on immigration issues.

Advocating this month will include signing a letter to Governor Michelle Lujan Grisham written by our non-profit partner NGage SUCCESS about the need for expanded broadband access to our county and all of southern New Mexico. Eileen will sign as co-chair of LWVNM Education Committee and Kathy will sign for LWVSNM.

Members have met with Sen. Carrie Hamblen, CEO of the Green Chamber this month, to discuss our participation in that group's activities. Carrie will help us get into the Chamber's social media sites and at some point, in the coming month we'll be inviting members to participate in a training session on the use of this widespread method for getting our message out.

The Woman's Improvement Association will be honored by the LWVSNM and the GFWC Progress Club by placing a Pomeroy Marker in Pioneer Women's Park. A program with KRWG TV during March (women's history month) will feature information about the WIS and voter suppression.

Kim, Erika, and Sadie will meet with Kathy to discuss budget needs and rework the budget in preparation for presentation at the League's Annual Meeting, April 13. The possibility of raising dues will be included. Jo suggested that since we're likely to be without the expense to members of our luncheon or dinner meetings for at least another half year, the money saved could be applied to elevating dues.

Eileen told us that her work with Meredith Machen, Co-Chair of the LWVNM Education Committee, has led to many changes in the state's education position, especially in regard to multicultural education. They're also working on a concrete definition of "high quality, equitable education system."

Progress continues with the Making Democracy Work Award. The specifics to this award will soon be reported in the local media and to League members. Stay tuned for a wonderful virtual event.

### Let's Meet LWVSNM Member ... Elisa Sánchez

I was born into and raised in a segregated mining community (Grant County), where Mexicans were treated as second class citizens. All of that began to change when several small unions were amalgamated into one union and Mexicans had power for the first time.

My mother was a leader in the Local 890 Women's Auxiliary who were essential in achieving union success with an important strike. The movie, *Salt of the Earth*, is a dramatized version of the revolution that gave us some semblance of rights and more importantly equal pay for equal work in the mine. My sister and I were at my mother's side, every step of the way, stuffing envelopes, marching on the line doing everything necessary to achieve social justice. On the picket line, I experienced

a solidarity I strive for even today because I saw what can be accomplished when people work together, trust each other, and struggle for a common goal.

My first act of personal rebellion in that segregated situation was with my high school counselor. My parents always talked to me about going to college and the counselor refused to give me the classes that I needed to apply - four years of English. I refused to take "no" for what I wanted/needed and basically told her I was not leaving her office until she gave me English 4. She finally relented and I was able to apply for and be accepted to the university. I now have three degrees. I have been a life-long activist for the rights of my community.

I joined the League of Women Voters with my husband, who had been a member for years before we met. I like their activism in issues that matter to me and I pledge to be an active member.

#### **BOARD OF DONA ANA COUNTY COMMISSION (BOCC) • Regular Meeting**

January 12, 2021

Observer: Jo Galván Nash

All members were present as was County Manager Fernando Macias

**New BOCC:** This was the first meeting with new County Commissioners Susana Chaparro and Diana Murillo-Trujillo. The Board selected Manuel Sanchez as the new chair and Ms. Murillo-Trujillo as Vice Chair for 2021.

<u>COVID Vaccines</u>: The CDC reports that NM is one of the leading states (#6) in the roll out of vaccines. There are health offices providing the vaccine across the county. Dawn Sanchez, regional director of the NM Department of Health, said they want more people to preregister for the COVID vaccine. Get your confirmation code online at <a href="https://cvvaccine.nmhealth.org/">https://cvvaccine.nmhealth.org/</a>. Then, individuals will be notified when they are eligible for their appointment. (No internet: call 1-855-600-3453.) She said they are working on logistics with many agencies for additional vaccine centers. Their goal is to administer 1,000 vaccines per day.

<u>Sheriff's Annual Report:</u> Sheriff Kim Stewart detailed the department's accomplishments during a Covid-impacted year, which created additional hurdles.

#### **Comparing 2019 to 2020:**

2019: responded to 65,000 law enforcement calls of all types

2020: responded to 77,000+ calls

- DUI's dropped but vehicle thefts increased
- Investigated fewer criminal felonies
- Residential burglaries down; commercial burglaries are up
- Rapes down from 63 to 20
- Child protected referrals dropped by 200 (Caveat: this doesn't mean that this problem is lessened, but school is not in session and teachers are primary reporters of child abuse.)

Equipment obtained in 2019 included rifles, vests, helmets, hand-held radios, and wireless capabilities for their robot. She also outfitted deputies with body-cameras and created a policy for that. The Sheriff's 2021 goal: everyone in the Sheriff's department to stay healthy. There have been 16 cases of COVID and all Sheriff's personnel recovered.

## **LAS CRUCES BOARD OF EDUCATION • Regular Meeting**

January 19, 2021

Members: President Ray Jaramillo, VP Carol Cooper, Secretary Teresa Tenorio, and Members Terrie Dallman and Maria Flores

Student musicians from Centennial High School (Bella Voce) and Las Cruces High School (Wind Symphony) took home honors from the 2021 NM Music Educators Association All-State performances. These groups were recognized at the Board meeting through a video-clip of their performances.



#### LCPS School Board (cont.)

Superintendent Trujillo congratulated students who received academic rewards. 2021 graduation ceremonies will occur on May 21 and 22 at the Field of Dreams. Some schools returned to small pods on campuses today for students in special education. By the end of the week, 800 employees will be vaccinated. Vaccination is optional at this time. The whole County must get out of the "red" rating for students to re-enter schools. It sounds like there will be increased possibilities of face-to-face pods coming soon. On Jan. 21, Superintendent Trujillo will have a live question-and-answer session for the community via Zoom.

NEA LC (teachers/certified) and CSEC LC (staff/classified) shared concerns about COVID leave that is no longer available from federal funds. Hopefully the school can work out ways to provide COVID leave for teachers and staff who need it. Students are also concerned about re-enter to schools.

Mr. Ellison provided financial priorities for the Fiscal Year 2022 budget development, which were approved by the Board.

- Emphasize the importance of air conditioning on new school buses.
- Provide opportunities for additional student learning days.
- Expand tutoring opportunities for students.
- Explore a savings structure from renewable energy projects to impact student success.
- Expand renewable energy projects, including solar power, electric, and clean energy opportunities.
- Expansion of online learning capacity, including increase cybersecurity infrastructure and increase professional development opportunities for online instruction.
- Increase the number of counselors and mental health support staff, especially at the middle and high school levels.
- Expansion of international Welcome Centers to all middle schools.
- Dedicate funding to ensure continued success of Student Advisory Council.
- Continue support for community schools.
- Review and expand support for culturally and linguistically responsive educational opportunities, including curriculum development for ethnic studies.
- Review a stipend for bilingual educators.

An equitable grading scale of middle and high school learning assessments for this year only was discussed. The scale means that with a minimum "F" grade, a student can receive 50% rather than 0%. A teachers' advisory group has formed to discuss equitable grading. Advice from the Student Advisory Council was also sought.

## LAS CRUCES CITY COUNCIL • Regular Meeting

February 4, 2021

Currently, there is no park in the Mesa Grande Road neighborhood that is readily accessible for young children, a problem Councilor Gil Sorg has been seeking to address for many years. One challenge has been the lack of two acres (the minimum recommended size for such a park) of land in the city in that area. A resolution was approved to proceed with a park on available land and to complete the park within a year.



#### LAS CRUCES CITY COUNCIL (cont.)

A second topic was creation of a Covid-19 task force for the city, as had been suggested at a recent presentation to the US Conference of Mayors. The focus would be on the roll-out of vaccines. The proposal was approved with Councilors Abeyta Stuve, Gandara, and Flores representing the Council on the task force.

There was extensive discussion of implementation of agreements between the city and various nonprofit partners for emergency assistance programs. Some nonprofits have not fully expended funds allocated to them, perhaps because they are trying to spread the service to clients over a period of months. (For example, meal vouchers at restaurants are being spread over several months in part to allow for adjustment by restaurants to more customers.) The Council approved a resolution to allow staff to develop and execute agreements for emergency assistance with nonprofits in amounts up to \$150,000.

#### LAS CRUCES CITY COUNCIL • Work Session

February 11, 2021 Observer: Kathy Brook

Operations of the Las Cruces Airport were discussed with a presentation by the airport manager. Elements of the presentation included the need for an appropriate fee and rate structure and simplification and standardization of lease language. Analysis indicates that a gradual increase in rates is appropriate. A second topic of discussion was the UTV ordinance approved in March to allow UTVs to be driven on city streets and a September modification of the ordinance to eliminate conflicts within the original ordinance which had precluded most UTVs.

The final topic and one of special interest for the League's Affordable Housing Committee was the 2021-2025 Consolidated Plan required for CDBG and HOME (Home Investment Partnership Program) funding. Crescendo Consulting is developing the plan for the City, including collecting census data and conducting a survey of community members. Their observations include an increase in the poverty rate for children, convergence of the median income for Hispanic households with white, non-Hispanic households, and a sizeable increase in the percent of the population over 65. The community survey revealed relatively consistent needs and priorities across race/ethnicity, income and age groups – the three top needs being economic development; mental health and substance abuse; and domestic violence shelters. These needs have been intensified by the Covid pandemic. The next steps will be an in-depth analysis of the data and identification of potential strategies and goals. There will be a 30-day public comment period before the final review of the document by the Council in April or May.
