The Equal Rights Amendment is a proposed amendment to the United States Constitution designed to guarantee equal legal rights for all American citizens regardless of sex. It seeks to end the legal distinctions between men and women in terms of divorce, property, employment, and other matters. "Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex." Although never ratified, the ERA remains the most popular Constitutional amendment to date.

League's partnership with *People First Alabama* (PFA), a group of people with developmental disabilities, was especially meaningful. Members of PFA share strategies for members to be self-advocates. In partnership with the League, work focuses on removing barriers to voting. The President of the LWV District of Columbia urged Leagues to advocate for D.C. Statehood.

March is Women's History Month and efforts to add the Equal Rights Amendment (ERA) to the U.S. Constitution are under way. On Jan. 31, 2023, there was a news conference to announce a joint resolution to affirm ratification of the ERA in both the U.S. House and Senate. A hearing of the Senate Judiciary Committee on how congress can recognize the ratification and add it to the Constitution occurred February 28<sup>th</sup>. On the same day, the nominee for the U.S. Archivist, Dr. Colleen Shogan, made a second appearance before the Senate Homeland Security and Governmental Affair committee. ## 3<sup>rd</sup> Annual Making Democracy Work Award Bestowed to County Clerk

Otero County Clerk Robyn Holmes of Alamogordo has been selected as the 2023 recipient of the Making Democracy Work Award from LWVSNM. Our league represents the counties of Doña Ana, Otero, Sierra, Grant, Luna, Hidalgo, Lea and Eddy.

"Robyn faced numerous challenges and defended voter rights, justified voting pro-



cedures, stood up for her staff, poll workers and poll judges," said Co-President Eileen VanWie. She stood up for "the values supported in our democracy, which include respecting the rights and fairness of all citizens to vote without intimidation. The League gives her this award to honor her professionalism, honesty, and commitment to election processes."

"I am humbled to receive this honor and feel privileged to have served the voters of Otero County for all these years," Holmes said. "Fair elections are the bedrock of our democracy."

Several LWVSNM Board members plan to present the official award at the Otero County Commission meeting on Thursday, March 9. Several members of the league's Otero County unit are also expected to attend.

"This award annually honors someone who is civically engaged, and someone who also promotes what the League supports — justice, equity, diversity and inclusion," added

The 2023 high school seniors voter registration drive is underway. League Voter Registration Agents and staff from the County Clerk's office are meeting with Doña Ana County seniors in their high school government classes and are offering them the opportunity to register to vote. League members from the new Otero county unit are considering implementing a similar registration drive.

So far, 143 students registered at Gadsden High School on February 22 and registrations also took place at Gadsden's Alta Vista Early College High School and at Alma d'arte Charter High School in Las Cruces on Feb 24. Las Cruces Public Schools will start its registration drives in early May.

Doña Ana County Clerk Amanda López Askin has facilitated the sessions as her schedule permits. She brings authenticity, humor and gravitas to the events.

    MDW Award Recognition: K. Brook reported that the Board voted on three applicants that were submitted for the Making Democracy Work Award, and indicated that Robyn Holmes was the winner. A motion was made by K. Brook to accept the Board vote and dispense the MDW Award; it was seconded by K. Kanim. The motion carried unanimously.
    - **Threats to Democracy NM Listens Video:** Dr. Jamie Bronstein of NMSU's Department of History. Dr. Bronstein will discuss threats to democracy now and throughout history.
  - b. March 11 Women's History Month: K. Brook suggested an open member discussion on how our lives are/were/were not affected by the Equal Rights Amendment (ERA).
- 3. Budget Committee Action Items:
  - K. Brook will email board members and committee chairs asking them to submit the dollar amounts needed for next year's budget to the Budget Committee.
  - K. Brook will ask Louise Marquez to convene the Budget Committee.
  - T. Kracji was asked to submit Otero County Unit's expected expenses for the next year.
- 4. Local Law Enforcement and Crime: E. VanWie reported that Liz Rodriguez Johnson asked the League to send a message to its members encouraging them to attend a city council meeting where the OIR, the city's audit group for police complaints, will make a semiannual report. Some members of the community are proposing that Las Cruces create a Police Oversight Board.
- 5. Membership New Member Orientation Debrief: J. Aldrich reported that 11 members attended the New Member Orientation including three Otero County Unit members.
- 6. Update LWVNM Board meeting State Convention, April 29-30, 2023, Los Alamos: K. Brook reported that the League state convention will be held on the aforementioned dates. Any League member can attend the convention, but LWVSNM is allowed three voting delegates. Contact K. Brook or E. VanWie if interested in attendance as a voting delegate.
- 7. Nominating Committee Update: M. Flynn reported that the Committee is identifying good candidates.

Adjournment: A motion was made by J. Aldrich to adjourn the meeting; it was seconded by K. Kanim. The motion passed unanimously.

#### LAS CRUCES CITY COUNCIL • Regular Meeting

February 6, 2023 Observer: Kathy Brook

Public participation included Steve Fischman speaking in support of SB 165, sponsored by Sen. Carrie Hamblen and focusing on the electric needs of the local community; a report on a Desert Hope resident experiencing alcohol and drug issues; reports on vandalism and theft; and complaints about the condition of existing public restrooms and the plan for installation of hygiene stations.

The city's external auditor provided a report noting that the city provides additional information beyond what is required and was one of 18 governments in the state and one of 3 municipalities to receive an award for its financial reporting.

An appeal was denied concerning the granting of a special use permit for a cannabis dispensary near downtown. The appeal focused on the process. The permit allowed a dispensary within the 300' buffer with single family dwellings. (There is no such buffer for multi-family units.)

#### LAS CRUCES CITY COUNCIL • Work Session

Pedestrian Safety: Las Cruces is above the national average but below the state average of people killed on roadways. About 25% of fatal crashes involve someone walking. The city is working with a consultant on a safe systems approach to the issue. This means safety is viewed as a shared responsibility including users, system planners, and policy makers. Deaths are viewed as preventable rather than inevitable. Safe systems involve designing streets for the desired speed, prioritizing lower speeds. and physical separation of pedestrians from traffic.

Mobile Integrated Healthcare Team: The city's LIGHT program (Lessen Incidence of Grief, Harm, and Trauma) will go live on March 6. It serves those experiencing a crisis within the 911 system (not the 988 system), expanding the emergency response for mental health crises. Councilor Gandara urged communication with Memorial Medical Center concerning closure of the psych unit.

#### **SOUTH CENTRAL SOLID WASTE AUTHORITY • Regular Hybrid Meeting**

February 16, 2023, Transfer Station Board Room • 9:00 a.m. Observer: Johnnie R Aldrich

Priorities: The most important news for us does not come from this Authority meeting, but from a presentation by Brandi Misquez, the SCSWA Recycle Education Coordinator at the Good Samaritan Senior Living Village on Monday, February 13. The lecture about the recycling process included the UPDATE that all clean plastics are now recyclable. One exception: black containers of any kind are not accepted. "All" also does NOT include the so-called "film" plastics like single use plastic bags, bubble wrap, or products like Saran Wrap. However, we no longer need to check the recycle triangle on the bottom of containers for 1 or 2; all clean plastics, except for the black one and "film," are welcome in our blue bins.

Since this was the first regular meeting of the Authority since November, it was a lengthy one. The first order of business was election of the new Chair: City Councilor Becki Graham will serve as Chair.

Director Patrick Peck's Administration Report on his activities, besides the usual tonnage figures, included two items that led to extensive discussion.



#### SCSWA cont.

The first was the possibility of extending the usefulness of the dirt lot on Hadley Ave. that is now being used just for storing the 40,000 trash and recycling bins. Forty trucks are "on the road every day" and Peck suggested that leasing the lot and building a fleet maintenance facility there would greatly increase efficiency in that part of this multi-million-dollar service in addition to reducing the current cost of moving "crippled" trucks to the present maintenance facility. SCSWA would lease the property for 10 years for \$120,000 annually and the owner has agreed to build a workshop to SCSWA specifications. Authority members gave Peck permission to continue exploration of the details.

A second lengthy discussion occurred when one of the Board members asked about the possibility of curbside recycling in the county outside of city boundaries. Director Peck pointed out that this would help considerably with the problem of illegal dumping, which consumes extensive clean-ups by SCSWA crews. However, the need for additional trucks, dozers, and drivers would add significantly to the operational costs. No decision was made, but Peck will present anticipated specifics about those costs at the next quarterly meeting of the Board.

Some happy financial news: SCSWA will continue service at White Sands Missile Range in the coming year; income will be \$100,000 annually.

#### DAC - NAACP

February 18, 2023 Observer: Jennifer Kreie

The guest speakers at this meeting were Sheriff Kim Stewart and City Councilor Becky Corran. Sheriff Stewart talked about policing in general and some specific programs in her department.

- Sheriff Stewart described the six pillars of policing.
- She said the policy and procedures manual is available online.
- The Sheriff's Department is undergoing accreditation by the Commission on Accreditation for Law Enforcement Agencies. This is the gold standard for accreditation.
- Sheriff Stewart said the department's disciplinary actions are posted online, though personal identification data has been removed.
- Department programs that Sheriff Stewart described were:
  - Amigos de DASO Senior Program. A deputy is paired with a qualified senior and the officer contacts that senior at least once a month.
  - Victim Assistance. Recently the department has operated a test run of a "Will you leave right now?" program that offers money for travel, short-term housing, or other assistance that enables a domestic violence victim to get out the situation <u>immediately</u>, at the time the officers are there. The department received a \$30,000 grant in support of this program and renewed funding is expected.
  - Sheriff Stewart said to keep in mind that the County Sheriff's office serves the <u>unincorporated</u> parts of the county, not within city limits in the county.
- Sheriff Stewart said more needs to be done for crisis intervention training, such as in-person, role-playing practice for officers. Online training isn't sufficient.
- She said people leaving their guns in vehicles is a big issue. Guns should be secured, not casually stored. There should be a penalty for irresponsible gun ownership (*my paraphrase of what she said*).

Becky Corran is the City Councilor for District #5.



#### **DAC-NAACP** cont.

Councilor Corran:

- Short-term there should be discussion about reports, such as the one from OIR scheduled for the 27th of February. Work is being done to get a City Council work session scheduled to address issues citizens' concerns about transparency when a police action has been reviewed.
- Longer-term there should be discussion of policy changes that may be needed for the police department. The ACLU NM has been contacted for information about policing policies this agency thinks have been successful.
- Councilor Corran pointed out that a significant majority of comments made to councilors is about the need for more police presence near local businesses and in the communities. The concern expressed most often is for personal safety from criminal action rather than whether the police response was justified. She said it is important the council hear from people concerned about police policy and extreme measures/overreactions. In other words, people need to attend and speak at city council meetings.
- Mayor Pro-Tem, Kasandra Gandara was at this meeting and she reinforced Councilor Corran's point that people need to attend and to speak at city council meetings. Build a relationship with your city councilor, as well.

#### LAS CRUCES CITY COUNCIL • Regular Session

February 21, 2023 Observer: Kathy Brook

Public participation topics included lack of a spay and neuter ordinance in Las Cruces, crimes against small businesses, public concern about use of force issues involving police officers, pollution by leaf blowers (especially those in use by the city), closure of the psych facility at Memorial Medical Center.

A major agenda item was approval of \$17 million of the \$23 million of GO bonds approved by city voters last November. The bond issue for affordable housing was delayed to later this year or to 2024 because the housing bonds will be taxable and, according to the city's bond advisors, a better interest rate might be available at the later date. Two percent of the bonds are allocated for public art (with 0.25-.05% available to use in restoring or conserving public art. It may be possible to proceed with housing projects before those bonds are issued -- with reimbursement later after the bonds are issued. (Observer comment: the rationale for delaying the affordable housing bond issue was not clear. There may also be a better rate on tax-exempt bonds at a later date.)

Councilor comments: Councilor Graham reported that she and Councilor Bencomo met recently with junior leadership (high school juniors from area schools).



#### LAS CRUCES BOARD OF EDUCATION • Regular Meeting

February 21, 2023 • 6:00 pm Observer: Eileen VanWie

Members Present: President Teresa Tenorio, VP Pam Cort, Secretary Robert Wofford, Carol Cooper, and Ray Jaramillo; and Superintendent Ralph Ramos

A welcome was given to Student Advisor Jeorjinah from Organ Mountain High School. The meeting began with the Pledge of Allegiance to the Flag in English and Spanish led by third-grade student Leah from Valley View Elementary. There was recognition of students for a variety of awards.

President Tenorio appreciated influential educator J. Paul Taylor, who died recently at 102 years of age. It was later suggested that Mr. Taylor be added to the legacy wall at the LCPS administration building, which the Superintendent said would happen.

Public comment included support for Superintendent Ramos who is under investigation; statements were made about PED making attacks on parents, and "my Board supports me because I'm a safe white guy;" a few speakers prefer Calendar B (traditional) and criticized the Board for not using the survey responses about it and one parent supported Calendar A (balanced); there is a need for more gender-neutral bathrooms in the schools; and statements were made about "sneaky things" the Alamogordo Superintendent did and is now placed on leave; and schools should post ethnic studies classes and Equity Council documents so there would not need to be so many Inspection of Public Records requests.

Discussion of the 2023-2024 and 2024-2025 calendars were on the agenda and created much discussion. The survey could have been worded better. Board members did read through responses to the survey. Results seem to be 50-50 on the two calendars. 70% of faculty approved the balanced calendar. Board members generally thought more time was needed with the balanced calendar to assess how it's working. A motion to approve school years 2023-2024 and 2024-2025 with the balanced calendar was made and passed on a 5-0 vote.

Several policies were discussed and approved or moved forward to another reading. Staffing throughout the district is now is 96.85% complete. There was an independent financial audit report for the year ending June 30, 2022. Several areas were significantly deficient and will be corrected.
