An item of considerable interest to us locally was the discussion at the state board meeting, following the convention, of our proposal to change our name from LWVGLC to LWVSNM. The board approved our plan, so our next step involves working through the matter with LWVNM. They did recommend, however, that we try to geographically define southern New Mexico and made us aware of how large Congressional District 2 is. Noteworthy, given the discussion of this topic at our annual meeting, was the observation from LWV Central New Mexico that they have not yet attempted to

activities, good food, and stimulating conversations. The LWVNM Officers made sure we received detailed information on revised NM positions and bylaws, as well as future programs for study and action.

There were many changes to positions, including Civil Discourse, Election Procedures Education, Gun Safety, Health Care, Immigration, and Net Neutrality. A new position was approved on the Transfer of Federal Public Lands, which you'll find included in *The*

Voter (see below). Board members felt this position should be taken forward to the LWV US for concurrence with New Mexico.

The LWV Santa Fe County received an endowment established by Past President Meredith Machen called the *LWVSFC Diversity Fund Guidelines*. Meredith provided funding for the same purpose to the LWVNM. The goal is to remove the cost of membership as a barrier to more diverse membership, identified as "including age diversity, ethnic diversity, and diversity in volunteer skills." Members who receive this benefit would agree to be an active member through a specific activity or as part of a project approved by the leadership team. Diversity of our local League membership is a topic for future discussion.

The LWVNM History Committee is planning a few events. On the 100th anniversary of the League of Women Voters, Friday, February 14, 2020, there will be birthday cake served at the Roundhouse and key legislators will be asked to sponsor a memorial commemorating the centennial, including NM's ratification of the 19th amendment on February 21. February 14 will also be the League's Legislative Reception day. On Saturday morning, August 22, the LWVCNM (Albuquerque) is planning a parade. They are envisioning that the City and other organizations will participate. The LWVNM History Committee plans to request a program at the National Park Service Headquarters Courtyard for Sunday afternoon, August 23. Perhaps weekend dates are more appropriate than the actual date the 19th Amendment was added to the Constitution (August 26).

The 2019-2020 LWVNM calendar was discussed. The Board plans to meet in Las Cruces on November 16, 2019. We will be scheduled to host the LWVNM State Convention in May of 2021.

LWVNM – May 19, 2019 • Transfer of Federal Public Lands – New Position

The League believes that federal public lands should benefit all Americans. The lands should remain under the jurisdiction of the federal government and be managed according to the Multiple-Use Sustained-Yield policy. We support improvements in management and regulation.

Federal law allows for the sale or exchange of federal lands if it is in the public interest. Prior to any transfer, a comprehensive assessment that covers the following issues should be performed:

- environmental analysis, including air and water quality, biodiversity, endangered and threatened species
- health impacts
- environmental justice
- suitability of proposed land use
- subsurface resources

- financial/economic impacts
- cultural resources
- public access
- management for fire and other natural disasters
- tribal consultation.

The League is opposed to the sale of federal lands to private entities except for small tracts surrounded by nonfederal lands. The League is opposed to the transfer of subsurface rights to the state or other entities. Any development of subsurface rights on federal land should benefit all Americans.

Additions to League Board of Directors

In addition to the recent election of a new slate of League Officers for 2019/20, two members were appointed to one-year terms for Director positions. Erika Graf-Webster, a longtime League member and former President will continue her successful work with youth engagement. And, new member Jo Galván Nash will break ground in a new League position – Director of Public Relations.

Erika Graf-Webster -Youth Engagement Director

Erika Graf-Webster spent most of her 40plus-year career in computer science, systems analysis, project management and technology consulting. She has worked on numerous government contracts in the defense and intelligence industries. She retired in 2007 when she moved to Las Cruces. Upon arrival, Erika joined the League of Women Voters of Greater Las Cruces and has served as Director of Voter Services, Vice President, President and Director of Youth Engagement. She led a study identifying impediments to voter registration in the Hispanic community, which led to the development by the League of targeted voter information stressing the importance and value of voting.

In 2014, Erika founded the League's Youth Engagement Committee, which she continues to chair. The mission is to motivate and engage young people to become active members of the community, active citizens and voters. The committee's ongoing Civic Engagement Project with the Las Cruces Public Schools works to enhance the civics and government curricula at all levels. In October 2018, the project "Celebrating Democracy in Doña Ana County" was a great success, when over 300 students, 23 candidates and 60 volunteers participated.

Board of County Commissioners (BOCC) • Regular Meeting

May 14, 2019 • County Govt. Center Observer: Jo Galván Nash

All 5 Commissioners plus County Manager Fernando Macias were in attendance

In a report on the Federally Qualified Health Center (FQHC) services to the County, Director of Human Resources Jamie Michael said there are three clinics that will continue county services for the next four years: Amador Health Center (the smallest), Ben Archer Health Center, and La Clinica de Familia. These clinics "are the cornerstone for indigent care" in the county, she said.

For the 2018/19 fiscal year (through April) the most common reasons for patient visits were: high blood pressure (254 patients), immunizations (182), and diabetes or complications related to diabetes (141). Mental health and dental care are also provided, among other medical issues.


The County's reimbursements to the centers for the current fiscal year (through April) through the GRT indigent fund are:

• Amador Health Center - \$174,600

• Ben Archer Health Center - \$748,848 and \$19,999 (General Fund for Circle of Security)

• La Clinica de Familia - \$377,589 and \$322,752 (Federal grant funds for Assisted Outpatient Treatment not indigent funds).

The centers also provide school interventions such as behavioral health and medical care.

Las Cruces City Council • Regular Meeting

May 20, 2019, 1:00 p.m. • City Council Chambers, City Hall *Observer: Johnnie R. Aldrich*

All 7 Councilors present; Greg Smith telephonically

Opening Ceremonies included Mayor Miyagishima's presentation of the Mayor's Distinguished Service Award, probably the highest honor awarded to city citizens, to CHRISTINA LITTLE. (NB: Jane Asche received this same award last year.) The award recognizes Christina's role, during the past 15 years as Founder and Convener of the Interagency Council. The council facilitates communication and coordination of social services in the city. Mayor Miyagishima commented "...there's nothing like it in any other city of comparable size in the U.S." He also noted her active participation in LWV since 1974 and numerous other roles she's taken on in her time in Las Cruces since 2000. KUDOS, Christina! (and William, who provided computer-savvy support for her multiple projects.)

The Public Participation segment included a plea from students at Las Montañas Charter School for city support for their efforts to raise awareness and provide support to students struggling with mental health issues. Their well-organized presentation described the "Drop-In Center" that they planned and facilitate in their school where students can find counseling and peer support in their search for mental health.

Over an hour of the meeting was devoted to one Old Business resolution to "accept and approve the Parks and Recreation Integrated Pest Management (IPM) Policy," which dealt primarily with the use of Roundup, especially at city facilities. Several residents presented cogent reasons for discontinuing its use, but councilors had objections to the wording and incompleteness of the Park & Rec Department's policy. Finally, the resolution was tabled indefinitely, which means that it will be reworked and presented again.

Multiple resolutions followed, in addition to adoption of the city budget for 2019-2020.

Televised Forum on Immigration Presented

Several members of the LWVSNM were present at an Issues and Answers Forum at KRWG-TV to discuss the topic of Immigration. The League co-sponsored the event which was taped on May 28 at the TV-22 studios on the NMSU campus.

Panelists included Nia Rucker, ACLU-New Mexico, Edith Tapia, Hope Border Institute, and Molly Molloy of NMSU. Be sure to watch the Forum at the following dates and times:

Meeting Administration:

1. Call to Order and Welcome

Co-President Eileen VanWie called the meeting to order at 10:03 AM.

2. New Board Members (Elected and Appointed) and Introductions

Eileen, Kathy Brook, Bob Burn and Jo Galván Nash are new to the Board. Each Board Member introduced him/herself. Erika Graf-Webster, Director of Youth Engagement Project and Jo Galván Nash, Director of Public Relations were appointed to one-year positions on the League Board at the brief Board meeting after the Annual Meeting on April 13.

3. Filling open positions on Board (Co-Membership and Development)

There were no suggestions for the positions of Co-Membership Director or Development Director. Erika Graf-Webster was appointed as Acting Secretary for the remainder of this League year.

4. Changes to Agenda

A discussion of the Website was added.

5. Minutes April 4, 2019

The April Board Meeting Minutes reviewed. One change was made: on page 3 within the first bullet, the name "Debbie Michael" was changed to "Jamie Michael".

Reports:

1. Treasurer's report

William Little had submitted this report, dated May 1. No membership checks were processed during the past month. The treasurer will issue a check for \$275 to Kim Sorensen to reimburse her for the 501(c)(3) application. The current check book balance is \$6,383.43. The Treasurer's report was accepted for the LWVGLC file.

Bob Burn, the new Treasurer, mentioned <mark>that the check-signing authority will be changed to his and Kathy Brook's names</mark>. Bob said that he will establish a standard process for tracking incoming membership payments on a monthly basis so that the Board will always be up to date.

Dale Yeo said that she purchased a new domain name for our website, lwvsnm.org, in preparation for our name-change to LWVSNM. Dale also recommended that the League purchase a credit card processing "square" that can be attached to a smart phone, so we can collect payments at any of our events. Dale will research where to buy this, its initial cost, the fee for processing each credit card swipe, and how the money is then transferred into our bank account.

Kim Sorensen mentioned that <mark>the LWVGLC financial records need to be reviewed/audited annually, at the start of the new League year. Kathy will contact Johnnie Aldrich, who has done this in past years.</mark>

2. Membership

In a prior meeting, the suggestion had been made to establish a "members only" segment of our website, where League-sensitive information, such as our membership list with contact information, can be kept up to date. Maryellen Kebbel asked if that could be implemented. Dale, who also serves as our webmaster, will investigate.

Maryellen announced that a "New Member Orientation" has been scheduled for 10:00 AM on Saturday, June 1, at Eileen's house.

Maryellen agreed that she would keep our membership email list current (there had been some complaints from new members that they did not get notices of our meetings).

There was some discussion about having a League account that offers a discount at one of the local office supply businesses. Erika mentioned that we used have one at Staples, and that account might still be viable. Maryellen will check on this.

Erika said that she would like to again pursue getting an intern from NMSU. She will try to set up a meeting about this with Dr. Christina Medina, vice-chair of the NMSU Government Department. Eileen and Kathy Brook will be included in such a meeting.

3. Public Relations

Jo Galván Nash said that she has sent a press release to all the local media about the new Board and its goals. <mark>She will also try to get notices about our monthly meetings into the media calendars</mark>.

Eileen mentioned that she had some concerns about the lack of diversity in our League. <mark>Jo offered to do a</mark> <mark>little survey about this and bring a draft to the next Board meeting.</mark>

4. Voter Service

Vicki and Dale announced that printed copies of the new Who's Who are available and will be made available at the general meeting on May 13.

Kim talked with Fred Martino – KRWG would like to do three candidate forums with the League this fall: City Council (2 seats are up for election), Mayor, School Board. Kim also mentioned that the Elections Advisory Council (EAC) is working on creating public information materials about Rank Choice Voting (will be used for City Council election). Kathy Brook said that perhaps we should have a Unit Meeting on this subject.

5. Youth Engagement

Erika talked about the Harvard University "all expenses paid" Case Method training opportunity for which local Leagues are invited to submit candidate Civics or History teachers. Through the collaborative Civic Engagement Project between the League's Youth Engagement Committee and the Las Cruces Public Schools, Civics and History teachers were invited to apply. One teacher, Julie Wojtko, has submitted her application. Erika distributed a Letter to the Editor explaining this program. Jo felt, and the Board concurred, that this should be a Press Release, not a Letter to the Editor. Erika will send Jo the text and a photo of Julie, and Jo will develop the News Release.

6. Immigration

Kim announced that, with the collaboration of KRWG, there will be an Immigration Forum focusing on the current migrant crisis. Panelists will be Molly Malloy, NMSU Researcher; Edith Tapec, Hope Border Institute; and hopefully Rubin Garcia from the Annunciation House in El Paso. The taping of this forum will be on May 28, at 1:00 PM, and will be broadcast on June 13. Kim hopes that many League members will attend and ask questions. The Immigration Committee is currently developing questions for this forum.

Kim and the Immigration Committee will also be meeting with our US Congress Representative, Xochitl Torres Small, on May 13 to discuss the current Immigration issues. Kim will also talk about the Immigration Committee's work at the LWVNM Board meeting.

7. Program (Upcoming Unit and General Meetings, Plus Time and Place of Meetings)

a. Membership Meeting Programs

Speakers for the May and June membership meetings are set: Carrie Hamblen of the Green Chamber of Commerce will speak in May, and Fernando Macias, Doña Ana County Manager, will be featured in June. A unit meeting on ranked choice voting was suggested for the August meeting.

Former League member Sharon Shoemaker has suggested that we have a discussion about a New Mexico "Public Bank", for which the LWVNM is advocating. The state League would probably send down a speaker on this subject. A possible date for this would be our November membership meeting.

b. Meeting Place

There had been discussion in prior Board meetings about the possibility of changing the location of our monthly membership meetings. Cindy Murrell was to do a survey. Eileen will check with her. We could check out the Woman's Improvement Association (WIA) building across the street from Pioneer Women's The Park as a possible location. Alma d' Arte Charter School has a culinary program and might be able to provide lunch.

c. Future Meeting Topics

Eileen asked if our League should resurrect the Education Committee. There are a lot of things going on in NM related to education. There was no consensus on this proposal. The results of the Yazzie/Martinez v. State of New Mexico lawsuit was addressed somewhat in the NM Legislature by raising teacher salaries and including culturally and linguistically responsive education support. The Community Schools program and the need for social emotional learning skills in the curriculum were mentioned as an interesting topic for a future meeting. Jo said that Betty Patterson, former President of NEA-NM, might be a good speaker about education and the continuing challenges in NM. Also, possibly someone from Ngage might be invited. Dale suggested that we put some information about the Lynn Community School on our website.

Other Items:

1. Bonnie Burn Scholarship

Bob announced that the scholarship has been awarded to an Centennial High School student. He said he funded the endowment of the scholarship, but additional League contributions would be welcome.

2. Status of 501(c)(3)

Kim said that all the paperwork has been submitted. Hopefully, we will hear something within two months.

3. Our Website

Dale said that the Membership form on our website got corrupted. In addition, some changes to upgrade our website would be worthwhile. Erika recommended that "WeAreIT", a small IT business started by Ngage, be contacted to help us with this – they work at a discount for local Non-profits. Eileen said that she would send Dale the contact information (phone:575-521-0111). Erika requested that the Membership form be revised to include a line for "School" for student members.

Dale asked if she should establish emails for the officers (for example: <u>president@lwvglc.org</u>) on the website. Dale will set up this arrangement for Eileen to receive email sent to the president when our name change is in place. (Kathy is working with the financial components of the president's role.)

4. Development and Fundraising

The Presidents need to find someone who is willing to take this over and chair a committee.

5. Collaborative 2020 Celebrations 100th Anniversary of LWV and 19th Amendment

Eileen said that the State League would like us to identify some local suffragists. Their activities could result in the placement of a metal marker as a symbol of "votes for women" to be place in a public location in Las Cruces or Doña Ana County.

Gwen Hanson has agreed to chair the 2020 Celebration committee. Other organizations, such as AAUW and the LCPS Civic Engagement Project teachers are willing to collaborate. An initial meeting date will be set for the collaborating organizations in May.

6. Orientation Event for New League Members

This will take place on June 1.

7. LWVNM Convention - May 17-19, 2019, Los Alamos

Our League has five delegate slots. LWVGLC members who will attend include Eileen, Kim, Tom and Gwen Hanson and Kathy Brook. LWVGLC will offer to hold the 2021 LWVNM convention in Las Cruces. Our members will share information about our work on Immigration and Youth Engagement.

The proposal to change our name change to "League of Women Voters of Southern New Mexico" will be made at the next LWVNM Board meeting.
